# Frequently Asked Questions (FAQ's)

I have a different expiry date/batch code/product to what has been recalled, is it OK to use? Yes, ONLY product that matches the details confirmed above is affected by this recall. If the product you have does not match this, then you are safe to continue using it.

#### I have served the product already, what do I do?

We are taking a precautionary approach based on advice from the FSA and advising these foods containing mustard, mustard powder or mustard flour must be withdrwan if raw materials are sourced from a specific supplier. If you or your customers experience any illness/injury then they should seek advice from their GP or 111.

## I have the affected product, but I don't see there is anything wrong with it/I need to use it, can I just use the product?

We appreciate the product may look OK or that you may be left short of ingredients however, you **must** follow the instructions on the recall notice and dispose of the stock you have. We cannot accept any liability for any issues arising from customers choosing to ignore recall instructions
